- **PeoplePerHour:** This platform allows legal professionals to post offers or bid on projects. The average rate for contract drafting starts at \$100 per project. Experienced freelancers can demand fees as high as \$1,500 per project, especially for detailed, high-value contracts.
- **Freelancer.in:** With a large pool of clients in India and abroad, Freelancer.in allows legal professionals to bid on projects with an initial range of \$75 to \$200 per contract. Depending on the project's scope, complex contracts for international clients can fetch up to \$2,000 or more.

In some cases, fees can reach as high as \$30,000 per project, particularly for contracts involving multinational companies.
