Eligibility Criteria

1. For Applicants of CBSE, ISC and other State Boards minimum 60% aggregate score is mandatory.

2. All IB Diploma and IB Certificate students with 24 points with 3 subjects at HL and 3 subjects at SL may apply.
3. For Applicants of Andhra Pradesh, Telangana, Tamil Nadu & Kerala State Boards minimum 70% aggregate score is mandatory.
4. Cambridge/IGCSE board students are required to have 2 A-levels.

Admission Criteria

- Class 12th Board examination score accepted for admission.
- Essay writing.
- Personal Interview.
