CLAT 2025 Final Answer Key

The CLAT 2025 Final Answer Key was released on December 7th, 2024. As predicted, 4 questions in the Logical Reasoning Section were withdrawn. Accordingly, the evaluation of candidates for the CLAT 2025 UG took place out of 116 marks in place of the originally announced 120 marks.

CLAT 2025 Provisional Answer Key

The **CLAT 2025 Answer Key** will be released on December 2 at 4 PM on the CLAT Consortium Website. Candidates can access and download the official answer key in PDF format from the CLAT Consortium's website at consortiumofnlus.ac.in once it becomes available.

Candidates will have the chance to challenge any errors in the Master Question Paper or the Provisional Answer Key during the designated objection period. After the objection window closes, the Consortium will publish the Final Answer Key.

It is important to note that no further challenges will be entertained once the final version is released. Shortly after this, the CLAT 2025 results will be declared.

3. Check the notifications for the Answer Key and Master Question Paper.
4. Click on the provided link to download the answer key PDF.

How to file objections against the Questions or Answer Key of CLAT 2025?

- You can file the objections (if any) at the CLAT Consortium website.
- Objections received over email, support tickets on the website or phone calls will not be entertained.
- A fee of Rs. 1,000/- (Rupees One thousand only) is to be paid for each objection. If the objection is found to be valid and sustained, the said fee will be remitted to the same account from which it was paid.
- No requests for deposit of the amount in any other account will be entertained.
- No objection will be entertained without payment of the prescribed fee.

How to calculate the total marks obtained in CLAT 2025?

- Add 1 mark for all the correct answers and deduct 0.25 marks for each incorrect answer.
- Don't add or deduct anything for unanswered questions.
- Add total number of marks obtained from correct answers, multiply the number of wrong answers with 0.25 and then deduct it from the total marks obtained.
