1. Eligibility:

1. Participants must be law students (pursuing LL.B.) or LLM students.

2. Format and Structure:

1. The quiz will consist of 100 multiple-choice questions (MCQs).
2. The total marks for the quiz will be 100, and the duration is 90 minutes.
3. The quiz will be conducted on our online portal, accessible only during the scheduled time.

3. Remote Proctoring:

1. The quiz will be remotely proctored to ensure fairness and transparency.
2. Any deviation from the quiz screen more than twice will result in automatic disqualification, and the quiz will immediately end.

4. Technical Requirements:

1. Participants must have a stable internet connection and a device with a functional camera and microphone for proctoring purposes.
2. Ensure your device is fully charged to avoid interruptions.

5. Rules During the Quiz:

1. Each question carries 1 mark. No negative marking for incorrect answers.
2. Participants are prohibited from opening additional browser tabs, apps, or using external resources.
3. Once the quiz timer starts, it cannot be paused or restarted.

6. Tie-Breaker:

1. In case of a tie, the participant who completes the quiz in the shortest time will be declared the winner.

7. Disqualification:

1. Any form of malpractice, including seeking external help, switching screens, or cheating, will result in immediate disqualification.
2. Technical glitches caused by the participant's device or network will not warrant a redo.

1. Cash prizes will be awarded to the winners. The decision of the organizers will be final and binding.

9. Registration:

1. All participants must complete the registration process before the deadline. Late registrations will not be entertained.
