Private vehicles contribute significantly to air pollution, fuel consumption, and traffic congestion. Investments in reliable public transport can reduce emissions while improving the quality of urban life. However, large infrastructure projects often face delays due to funding constraints, land acquisition challenges, and administrative inefficiencies. These obstacles highlight the complexity of balancing development, environmental sustainability, and public welfare.
